

**ARKANSAS LOTTERY COMMISSION**  
**ARKANSAS 50/50 RULES**

**A. General Provision**

1. The Arkansas 50/50 Game Rules are comprised of (1) the Arkansas Scholarship Lottery Act; (2) the Arkansas Lottery Commission (ALC) Operational Rules; (3) the ALC Rules for Claims in Contract or Tort; and (4) the Arkansas 50/50 Rules. Each numbered item cited above shall have equal weight unless there is an inconsistency between or among the documents, in which case the document listed first shall be controlling.
2. These rules may be amended at the ALC's discretion.

**B. Ticket Purchases**

1. The price of an Arkansas 50/50 ticket is five dollars (\$5.00).
2. Tickets are printed by an ALC retailer using the online terminal.
3. There is no playslip for Arkansas 50/50. Ticket numbers cannot be selected manually.
4. Tickets will be generated in sequential order, beginning with 000001. There will not be duplicate ticket numbers for a draw. Ticket numbers will begin again at 000001 after each draw. There will be one (1) play per ticket.
5. Tickets cannot be canceled.
6. If the player receives a damaged or illegible ticket or if the terminal fails to produce a ticket, the retailer shall provide the player with a new ticket. The retailer should retain the damaged ticket, if possible, and contact ALC.
7. A ticket is valid for one (1) draw.

**C. Draw**

1. Draw sales begin on the first day of every month and end on the last day of every month. Draws will be held on the first Tuesday of each month.
2. The winning numbers in a given draw are the numbers entered into the central gaming system and are controlling as to validation of a ticket by ALC or by an ALC retailer. If an error occurs during the entry process, ALC may correct an entry error and authorize validations accordingly.
3. Draws will be conducted in a manner prescribed by and under the supervision of ALC Security.

4. The winning ticket numbers shall be chosen by a computerized random number generator at ALC offices in Little Rock, Arkansas. The draw date and location may be changed at the sole discretion of the Director or designee.
5. Twenty-five (25) winning numbers will be selected in each draw.
6. Fifty percent (50%) of sales during the month preceding the draw will be allocated to prizes. Of that amount, seventy-five percent (75%) will be won by one (1) ticket number. The remaining twenty-five percent (25%) will be divided among twenty-four (24) winning tickets.
7. Draw results will be announced following internal verification of the winning numbers. Winning tickets may be redeemed once the winning numbers have been verified and announced.
8. A player wins if the number on his or her ticket matches exactly, with digits in exactly the same order, any winning number drawn by ALC.

**D. Prizes and Odds**

1. There will be a total of twenty-five (25) prizes per month, including:

Prizes awarded will be rounded up to the nearest dollar.

2. All odds of winning vary depending on the number of tickets sold.
3. The prize pool will consist of fifty percent (50%) of sales for the period from the first day of a month through the last day of the month. A new prize pool begins on the first day of the next month.

**E. Claim Procedures**

1. Prizes of five hundred dollars (\$500.00) or less can be claimed at any ALC retailer or claim center.
2. Prizes over five hundred dollars (\$500.00) must be claimed at an ALC claim center.
3. Prizes over one million dollars (\$1,000,000.00) must be claimed at the Little Rock Claim Center, 124 West Capitol Avenue, Little Rock, AR 72201 (1st Floor Union Plaza Building).

4. Prize claims may be mailed to ALC, P.O. Box 3838, Little Rock, AR 72203. Prize claims must include a completed ALC claim form.
5. All prizes are subject to all applicable taxes and debt setoff. A prizewinner's ultimate tax liability will depend exclusively upon the winner's other personal income and deductions.

**F. Claim Period and Ticket Responsibility**

1. All prizes must be claimed within one hundred eighty (180) days of the draw date in which the prize was won. Any prize not claimed within that period and in the manner specified above will be forfeited.
2. A ticket is a bearer instrument. Players should fill in the claim information in the space provided on the reverse side of the ticket and sign the ticket immediately after the purchase. The individual presenting a ticket for validation is presumed to be the owner of the ticket, and ALC assumes no liability for claims made by third parties.
3. A terminal receipt shall not constitute evidence of ticket purchase. The printed ticket is the only valid receipt for claiming a prize.
4. ALC will not be responsible for lost or stolen tickets or for tickets lost in the mail, mailed to an incorrect address, or mailed to an address other than the address specified by ALC to receive prize claims.
5. ALC will not be responsible for tickets claimed by a player in error for a lower prize at a retailer.
