ARKANSAS MILLION DOLLAR RAFFLE 2010/2011 RULES

A. General Provision

1. The Arkansas Million Dollar Raffle Game Rules are comprised of (1) the Arkansas Scholarship Lottery Act; (2) the Arkansas Lottery Commission Operational Rules; (3) the Arkansas Lottery Commission Rules for Claims in Contract or Tort; and (4) the Arkansas Million Dollar Raffle 2010/2011 Rules. Each numbered item cited above shall have equal weight unless there is an inconsistency between or among the documents, in which case the document listed first shall be controlling.

B. Ticket Purchases

1. The price of an Arkansas Million Dollar Raffle ("Raffle") ticket is ten dollars (\$10.00).
2. Tickets are printed by an Arkansas Lottery Commission ("ALC") retailer using the online terminal.
3. There is no playslip for Raffle. Raffle ticket numbers cannot be selected manually.
4. Raffle tickets will be generated in sequential order, beginning with 000001 and ending with 500000. There will not be duplicate ticket numbers. There will be one (1) play per ticket.
5. Raffle tickets shall continue to be available for sale until the final ticket (number 500000) is sold or end-of-day April 6, 2011, whichever occurs sooner.
6. A Raffle ticket cannot be canceled.
7. If the player receives a damaged or illegible ticket or if the terminal fails to produce a ticket, the retailer shall provide the player with a new ticket. The retailer should retain the damaged ticket, if possible, and contact ALC.
8. A Raffle ticket is valid for the one (1) draw described in section D. below and will not be valid for any future Raffle drawing(s).

C. Instant Prizes

1. Every twenty-fifth (25th) Raffle ticket generated will produce a coupon for an instant win of twenty dollars (\$20.00).
2. The ticket will show a message indicating that the ticket produced an instant win.
3. The instant-win coupon must be claimed at a licensed ALC retailer.
4. The Raffle ticket that produced the instant-win coupon is eligible to win a Raffle drawing prize. The instant-win coupon does not contain a number for use in the Raffle drawing.

D. Draw

1. One (1) draw is scheduled to occur April 7, 2011. The draw date may be changed at the sole discretion of the Director or his designee.
2. The winning ticket numbers shall be chosen by a computerized random number generator at ALC offices in Little Rock, Arkansas. The draw will be conducted in a manner prescribed by and under the supervision of ALC Security.
3. The winning ticket numbers as entered into the central gaming system are controlling as to validation of a ticket by ALC or by an ALC retailer.
4. One thousand one hundred forty-two (1,142) numbers will be drawn in the Raffle draw.
5. The first two (2) numbers drawn will each win one million dollars (\$1,000,000.00). The next five hundred and forty (540) numbers drawn will each win one thousand dollars (\$1,000.00). The next six hundred (600) numbers drawn will each win one hundred dollars (\$100.00).
6. Draw results will be announced following internal verification of the winning numbers. Winning tickets may be redeemed once the winning numbers have been verified and announced.
7. A player wins if the number on his or her Raffle ticket matches exactly, with digits in exactly the same order, any winning Raffle number drawn by ALC.

E. Prizes and Odds

1. There will be a total of twenty-one thousand one hundred forty-two (21,142) prizes available in the game, including:

2. If fewer than five hundred thousand (500,000) Raffle tickets are sold, only the instant-win coupons for the tickets generated will be awarded.
3. The drawing prize odds of winning and the number of instant-win coupon winners are based on five hundred thousand (500,000) Raffle tickets being sold, and would change if fewer tickets were sold for the draw.

F. Claim Procedures

1. Instant-win coupons worth twenty dollars (\$20.00) must be claimed at an ALC retailer.
2. Prizes of one hundred dollars (\$100.00) can be claimed at any ALC retailer or claim center.
3. One-thousand-dollar (\$1,000.00) prizes must be claimed at any ALC claim center.
4. One-million-dollar (\$1,000,000.00) prizes must be claimed at the ALC Little Rock claim center.
5. Prize claims may be mailed to ALC, P.O. Box 3838, Little Rock, AR 72203. Prize claims must include a completed ALC claim form.
6. All prizes are subject to all applicable taxes.

G. Claim Period and Ticket Responsibility

1. All prizes must be claimed within one hundred eighty (180) days of the Raffle draw date. Any prize not claimed within that period and in the manner specified above will be forfeited.
2. An online ticket is a bearer instrument. Players should fill in the claim information in the space provided on the reverse side of the ticket and sign the ticket immediately after the purchase. The individual presenting a ticket for validation is presumed to be the owner of the ticket, and ALC assumes no liability for claims made by third parties.
3. A terminal receipt shall not constitute evidence of ticket purchase. The printed ticket is the only valid receipt for claiming a prize.
4. ALC will not be responsible for lost or stolen tickets or for tickets lost in the mail, mailed to an incorrect address, or mailed to an address other than the address specified by ALC to receive prize claims.
5. ALC will not be responsible for tickets claimed by a player in error for a lower prize at a retailer.
