# Arkansas Department of Finance and Administration Office of the Arkansas Lottery <br> Term Contracts for Goods and Services <br> August 1 through August 31, 2017 

1. On June 28, 2017, the Department of Finance and Administration Office of the Arkansas Lottery (OAL) and Bank of the Ozarks entered into a Second Amendment to the Agreement for Contractual Services for Comprehensive Banking Services. The following information is provided:
a. Date of Agreement: June 28, 2017.
b. Term of Agreement: One (1) year, effective as of September 2, 2017.
c. Terms of Compensation: Interest shall be paid at the Federal Funds Rate plus . 20 (or 20 Basis points) with a start rate and floor of $.55 \%$.
d. Value (cost or cost savings projected for the agreement): The estimated net value is one dollar (\$1.00).
2. 3. On August 10, 2017, OAL and Advent Systems, Inc. entered into a one year extension of Lottery RFQ-130001, Arkansas Lottery Security System. The purpose of the extension was to ensure the continuity of security system equipment maintenance and service, pursuant to the agreement entered into between the parties (the Contract) on June 4, 2013. The following information is provided:
a. Date of Agreement: August 10, 2017
b. Terms of Agreement: One (1) year, effective as of September 1, 2017, with an option for renewal at a mutually agreed-upon price up to three (3) times in one (1) year increments or a portion thereof
c. Vendor or other parties to the Agreement: Advent Systems, Inc. and OAL
d. Value (cost or cost savings projected for the agreement): Cost of Service Agreement from September 1, 2017, through August 31, 2018, is $\$ 18,624.83$. Service calls for items not listed on the Equipment List or Service Calls that are due to OAL designated representative error or neglect will be billed at $\$ 65.00$ per hour. Advent will charge the after-hours rate of $\$ 97.50$ per hour for all work performed between the hours of 5:30 p.m. and 7:00 a.m., Monday through Friday and between 8:00 a.m. and 4:30 p.m. Saturday with a minimum charge per call of \$195.00.
1. On August 23, 2017, the Department of Finance and Administration Office of the Arkansas Lottery (OAL) and Intralot, Inc. (Intralot), entered into Amendment No. 3 to Contract Dated August 15, 2009 Between the Office of the Arkansas Lottery (Formerly, Arkansas Lottery Commission) and Intralot, Inc. The purpose of the amendment was to effectuate the implementation of an Extension to the Contract, pursuant to the agreement entered into between the parties (the Contract) on August 15, 2009. This amendment was reviewed by the Arkansas Legislative Council on August 18, 2017. The following information is provided:
a. Date of Agreement: August 23, 2017.
b. Vendor or other parties to the Agreement: Intralot, Inc. and OAL
c. Terms of Agreement: Intralot is granted by the OAL a seven (7) year extension to the Contract, commencing on the expiration of the current Contract (the "Extension Effective Date") on August 14, 2019, thereby extending the Contract through and including August 14, 2026.
d. Value (cost or cost savings projected for the agreement):
(1) Intralot will continue to be compensated at the rate of $2.165 \%$ of instant and online sales until December 31, 2017. Thereafter until the extension years expire on August 14, 2026, Intralot will be compensated at the rate of $2.11 \%$ of instant and on-line sales.
(2) Intralot will provide the following:
(a) 2,200 new PHOTON ${ }^{\text {TM }}$ terminals and printers to accommodate the reasonable needs of the retailer base. Deployment of the terminals shall be on a mutually agreed upon staggered basis which will commence in August 2019.
(b) 1,600 new PADS (Player Advertising Displays), to be deployed upon a mutually agreed upon schedule commencing after January 2018.
(c) A new BOS (Back Office System), including necessary upgrades of central systems equipment together with the most current version of ICS software and hardware implemented upon a mutually agreeable schedule during the 2019 calendar year.
(d) 400 new and unused Play Stations to include ongoing maintenance commencing in January 2018.
