The performance security should be made out to the ALC and will be on file at the ALC office.

In order to assure full performance of all obligations imposed on a Vendor by contracting with the ALC, the Vendor will be required to provide a performance security in an amount as deemed necessary by the ALC for this Request for Proposal within ten (10) business days from date of receipt of the ALC's written notification by mail of its intent to award. The form of security required shall be a performance bond such as is usually and customarily written and issued by surety companies licensed and authorized to do business in Arkansas or a cashier's/certified check. An irrevocable letter of credit from an Arkansas bank is also acceptable. The ALC shall award the Contract upon acceptance of the performance security. The performance security should be made out to the ALC and will be on file at the ALC office.

 <u>ATTACHMENT B – COST SCHEDULE</u> – Delete the number "6" from the Number of Units column on the Cost Schedule and substitute the number"4" for the service listed as "Online per account fee."
